1. **2 Years experience as Advocate-on-Record.**
2. **The applicant should furnish the list of important cases argued by him/her before the Hon'ble Supreme Court of India.**
3. **Preference shall be given to younger advocates.**
4. **Those who have already applied in "Prescribed Form" need not submit fresh application. Their pending applications will be considered along with fresh applications received pursuant to this circular.**

Kindly mention "**For Empanelment as Advocate-on-Record, SCLSC**" on the cover of the application moved.

Note:

1. **Incomplete application shall be straightway rejected.**
2. **The Committee reserves the right to select the suitable candidates, based upon number of the applicants, by adopting an appropriate criteria for analyzing the merit of the candidates.**
3. **Preference shall be given to younger advocates.**
